Playgroup Turn-Out Consent Form

In order to establish a safe and healthy environment for all participants in group turnouts, this facility requires that all dogs attending group play times have proof that appropriate vaccines have been administered and are current.

By initialing each section, I confirm that I have read and understand the following:

____ 1. I hereby certify that my dog(s) has received Rabies, Distemper, and Bordetella vaccines.

____ 2. I hereby certify that the above named dog(s) are in good health and, to my knowledge, have not shown clinical signs of any communicable disease within the last 14 days. I further certify that my dog(s) have not caused harm nor shown any aggressive or threatening behavior toward people or other dogs at any time.

____ 3. I understand that attendance by my dog(s) during group turn-outs involves group play with other dogs. Although the staff at this facility will closely supervise all participants, I understand that play behavior, unknown or undocumented aggression or, participation in routine daily activities, can lead to altercations or injuries. I hereby assume all the risks and responsibility for the costs to treat any and all injuries my dog(s) may sustain(s) while playing at this facility. I further understand and accept that in the absence of gross negligence, the owners of other dogs in the group play and staff will not be held liable for any injuries or deaths related to my dog(s) participation in this program.

____ 4. In the event my dog(s) contracts a communicable disease during the time (s)he is attending this program, I assume the risks and total responsibility for the costs of all treatments that may be necessary as the result of the occurrence of this disease. I also agree not to allow my dog(s) to participate in this program until (s)he has been free of any signs of communicable disease for at least five (5) days. Although risks of acquiring a communicable disease are small, I understand the possibility and, in the absence of gross negligence, I agree to hold the facility harmless for any and all expenses incurred for treatment.

____ 5. I understand and agree that if the need arises, emergency medical care for my pet will be sought from one of our staff veterinarians, and I agree to pay all costs incurred for such treatment. I have been informed that a staff member from the hospital will attempt to call me as soon as the situation is stable, and I will then be advised if further care is needed and, if so, I will be asked to acknowledge and agree to any additional treatment costs.

I have read this consent and understand that some risks always exist when groups of dogs are allowed to intermingle. I have been encouraged to discuss any concerns I have about those risks, and have had my questions answered to my satisfaction. I understand that this consent is valid for 6 months from the time it is signed and dated.

Outdoor Doggie Daycare is where your pooch wants to be! Outdoor Daycare is filled with the excitement of games while teaching and learning and making new friends! Your pooch will get to romp, run and wrestle with their favorite pals. Your pooch will get to play all their most desirable games in our large fenced in yards. At Offshore, we believe a tired pooch is a happy pooch and we guarantee that your best friend will come home exhausted from a day spent learning, playing and socializing!

Drop Off 8AM- 9AM for full day or ½ AM Daycare

Come in the front doors of Offshore Animal Hospital where you will be greeted by our lovely Front Desk Staff. There a Daycare staff member will greet you and your furry pal! “See ya soon Mom and Dad”, we are off on a great adventure to play! We have two big beautiful fenced in yards that allow pets to be off-leash in a safe environment. Pooch pals we be split up by size, temperament and compatibility!

Morning Training Session (9:30AM – 10:30AM)

Your pet will be participating in group obedience sessions! Everyday your pet will learn or practice commands and tricks in a structured game or obstacle course with all their friends.

Recess Pound Out #1 (10:30AM - 1PM)

GO GO GO!!! A canine romp session of tag, wrestle, chew, jump, run, tug, sniff and make new friends! Even learn new tricks and commands!

Afternoon Naptime ½ Day Drop Off & Pick-Up! (1PM-2PM)

Though it’s not required, we do offer downtime if pooches are sleepy! All pets attending the ½ day AM session, should be picked up between 1-2pm. If you pick up your pet later than 2pm there will be a **\$10 late fee**. All pets attending ½ day PM session should be dropped off between 1-2pm. If PM pets are dropped off late you will also be charged the **\$10 late fee**. It is very important to us that disruptions and distractions are kept to the bare minimum.

Afternoon Training Session (2PM-3:00PM)

A structured agility course (obstacle jumping), tunnel running or basic obedience performances will take place. This is a repeat of the morning training session.

Recess Pound Out #2 (3:00PM-4:00PM)

A canine romp session of chase, run, play hide and seek or rest

Scrub Down (4:00PM-4:30PM)

We will rinse, dry and brush your pet prior to going home! Any ½ day AM pets will get a scrub down between 12:30PM-1PM

Pick-Up (4:30PM-5PM)

Additional Furry Facts

Requirements:

Your pooch must be up to date on Rabies, Bordetella and Distemper Vaccinations. Puppies 3 months of age should have their Bordetella, at least 2 Distempers and a Rabies vaccination. All pets are required to have a fecal sample tested negative for intestinal parasites.

Please Note: To participate in our daycare program it is a requirement that we receive a negative fecal test result for intestinal parasites in order to allow your pet in our play yards.

We also require your pet to have an appropriately fitted collar or harness with an identification tag. We will be glad to help size one if needed. Prong collars or metal linked chains are not allowed. We do not want collars to interlock while the dogs are playing which can occur with prong collars.

Rates:

Full Daycare: \$40 per day or \$160 per week prepaid monthly.

½ Day AM or PM Daycare: \$30 per day or \$120 per week prepaid monthly.

Recurring weekly services: If you would like to schedule recurring weekly services (as many of our clients do) you will need to commit to at least 2 days per week to help provide structure for our social groupings. If you need to cancel services you must call (do not EMAIL) immediately to inform us of the cancelation. No call, no show prepaid payments will not be refundable.

Lunch Routines:

If you will be sending your pet to daycare with lunch, there is an additional **\$5 feeding fee**. Please send the food in a Ziploc baggie portioned to the correct amount with their name on it. Please no Tupperware containers! We cannot be responsible for losing them! Lunch will be between 11-12pm.

Weather Concerns:

Our outdoor daycare facility will be open during inclement weather! In case of severe weather that may cause unsafe conditions we may cancel or alter services. We will always try to give you notice. If Nantucket Public Schools close for inclement weather, so will Offshore's Doggie Daycare Program.

Dirty Paws:

Your pet may get dirty, especially on muddy days. However, our staff will always try to clean up a dirty pooch before going home. You can expect your pet to be rinsed off, towel dried, brushed out and given a scented pet safe spray that conditions their coat. Please understand some mess is inevitable and it only means that they had fun!
